Hais Txog: Sau Ntawv Hais Qhia Paub Ua Ntej Rau Tsoom Fwv Kev Kawm Ntawv Dawb Thiab Chaw Kawm Zoo Rau (FAPE) sij hawm tab tom Kaw Tsev Kawm Ntawv Mus Ntxiv Vim Yog Tus Kab Mob (COVID-19)

Hmov Tshua Txog (Cov) Niam Txiv/(Cov Neeg Saib Xyuas)

Fresno Unified School District (District) tau cog lus yuav ua kom tau txaus tej kev xav tau sib txawv rau cov tub/ntxhais kawm ntawv muaj IEPs sij hawm tab tom kaw tsev kawm ntawv rau qhov mob COVID-19. Nyob rau 34 CFR § 300.503(a) thiab tsab cai Individuals with Disabilities Education Act (IDEA), lub District tab tom npaj rau koj nrog sau daim ntawv hais qhia li yog nws yuav tsum tau muab kev npaj rau koj tus me nyuam tau Tsoom Fwv Kev Kawm Ntawv Dawb Thiab Chaw Kawm Zoo Rau (FAPE), yuav muab rub ntev ntxiv zoo yooj yim, los ntawm qhov kev nrug deb qauv qhia kev xyaum mus ntxiv sij hawm tsis paub/ntsis tau ua ua ntej dua li tej kev muaj rau qhov COVID-19 kaw tsev kawm ntawv. *Thov hais qhia paub tias qhov no yuav tsis muaj pauv koj tus me nyuam qhov IEP.* Thaum tsev kawm ntawv rov qab qhib kawm dua koj tus me nyuam qhov IEP ua tau zoo thaum cov tsev kawm ntawv tau kaw mam li rov qab ua mus ntxiv, ntshe yog IEP pab neeg rooj sib tham lossis pauv li yog tau muaj rau sij hawm tab tom kaw.

I. Kev Piav Qhia rau Qhov Kev Ua Uas Lub Sib Tham Rau Ua

Nyob rau qhov teb rau kab mob thoo plaws ntiaj teb thiab California's thiab Fresno's "Nyob Hauv Tsev Tsis Pub Tawm" "shelter-in-place" cov lus hais txwv (orders), District cov tsev kawm ntawv yeej tseem kaw ib yam qub. Lub District's Board of Education tau muab sij hawm kaw tsev kawm ntawv mus ntxiv rau qhov COVID-19 los ntawm qhov tag nrho kawm ntawv xyoo 2019-2020 no. Lub District tab tom muab kev ua kom paub tseeb qhov kev muaj ua tau txawm peem ua tau rau cov cib fim kawm ntawv thiab cov kev pab cuam qhia ntawv rau tag nrho cov tub/ntxhais kawm ntawv. Sij hawm qhov kaw tsev kawm ntawv rau COVID-19, lub District mam li muab kev npaj Tsoom Fwv Kev Kawm Ntawv Dawb Thiab Chaw Kawm Zoo Rau (FAPE) rau koj tus me nyuam rau qhov ntau ntxiv yooj yim los ntawm qhov nrug deb muaj qauv qhia kev xyaum. Sij hawm cov kev pab cuam/qhia ntawv no yuav tsum tau npaj siv nrhiav lwm cov kev xav tej hom kev qhia muab xa tawm thiab yuav muaj sib txawv los ntawm seb lawv yog tau npaj tsi ntsees li cas rau, lawv tau tsim muaj kom tau txaus koj tus me nyuam tej kev xav tau sib txawv sij hawm muab kev tiv thaiv rau qhov kev noj qab haus huv thiab kev dawb huv (health and safety) rau tag nrho District cov tub/ntxhais kawm ntawv, tej yim neeg, thiab cov neeg ua hauj lwm.

II. Kev Piav Qhia rau Vim Li Cas lub District Tab Tom Sib Tham rau Muab Kev Ua Ntawv

Raws li nyob hauv zos, xeev, thiab tsoom fwv cov lus hais txwv (orders) thiab tsoom fwv kev qhia ua rau kev noj qab haus huv, nws yuav tau ua npaj rau koj tus me nyuam nrog Tsoom Fwv Kev Kawm Ntawv Dawb Thiab Chaw Kawm Zoo Rau (FAPE) rau qhov kaw mus ntxiv kom yooj yim, los ntawm qhov nrug deb muaj qauv qhia kev xyaum, ua ntej yuav ua tau txaus rau koj tus me nyuam tej kev xav tau sib txawv sij hawm tej kev muaj tsis paub/muaj dua tau qhia nrog qhov COVID-19 kaw tsev kawm ntawv thiab kom paub tseeb tias muaj kev noj qab haus huv thiab dawb huv zoo (health and safety) rau tag nrho District cov tub/ntxhais kawm ntawv, tej yim neeg, thiab cov neeg ua hauj lwm.

III. Kev Piav Qhia rau Txhua Qhov Kev Ua Muab Luj Ntsuas, Kev Soj Ntsuam Tshau, Kev Sau Tseg, Lossis Cov Lus Hais Qhia lub District Tau Siv Nyob rau Muab Kev Txiaiv Txim rau Sib Tham Tsi Ntsees Qhov Kev Ua

Ua ntej yuav npaj rau koj tus me nyuam nrog Tsoom Fwv Kev Kawm Ntawv Dawb Thiab Chaw Kawm Zoo Rau (FAPE) rau qhov kaw mus ntxiv yooj yim sij hawm kaw tsev kawm ntawv qhov mob COVID-19, lub District tau rov qab xyuas dua thiab tau xav hais tias muab kho li cov lus hais qhia nyob rau nram qab no:

- A. Koj tus me nyuam qhov IEP tam sim no;
- B. City of Fresno’s City Manager’s Emergency Order 2020-02 tau tshaj qhia nyob rau lub Peb hlis tim 18, 2020;
- C. Governor Gavin Newsom’s Executive Order N-33-20 tau tshaj qhia nyob rau lub Peb hlis tim 19, 2020;
- D. California SB117, pib kaw lub Peb hlis tim 17, 2020;
- E. Kev qhia nyob rau hauv zos, xeev, thiab tsoom fwv cov koos haum saib kev noj qab haus huv; thiab,
- F. Kev qhia nyob rau lub California Department of Education thiab lub US Department of Education, muaj tag nrho lub Office for Civil Rights thiab Office for Special Education thiab Rehabilitative Services, tau tshaj qhia li yog rau hnuv tim rau cov lus qhia ua no.

IV. Kev Piav Qhia rau Txhua Lwm Cov Kev Xaiv Ua Tias lub District Tau Xav Hais Tias Muab Kho thiab Tej Nuj Nqis Zoo Vim Li Cas Cov Kev Xaiv Ua Ntawv Yog Tau Muab Tshem Tawm

Lub District tau xav hais tias qhov nuj nqis zoo nws yuav ua tau rau kev kawm ntawv tshwj xeeb thiab cov kev pab cuam/qhia ntawv muaj zoo ib yam rau koj tus me nyuam los ntawm qhov nrug deb muaj qauv qhia kev xyaum (distance learning model). Yog raws li nws tseem tsis tau paub thaum twg mam li rov qab tuaj kawm ntawv li qub txhua hnuv thiab muaj kev noj qab haus huv thiab kev dawb huv zoo (health and safety) rau tag nrho cov tub/ntxhais kawm ntawv, tej yim neeg, thiab cov neeg ua hauj lwm yog thawj qhov ua, lub District tab tom npaj rau koj tus me nyuam Tsoom Fwv Kev Kawm Ntawv Dawb Thiab Chaw Kawm Zoo Rau (FAPE), rau kaw ntev ua kom yooj yim, ua ntej yuav ua tau txaus koj tus me nyuam tej kev xav tau sib txawv thiab lub cib fim rau koj tus me nyuam yuav ua/kawm nyob rau tus tub/tus ntxhais kev kawm ntawv.

V. Lwm Cov Ntsiab Tseem Ceeb Nthuav Qhia rau Kev Ua No

- Thov hu mus rau koj tus me nyuam tus Case Manager rau txhua yam li nyob rau nram qab no:
 - Yog hais tias koj tus me nyuam tsis muaj tshuab technology (computer tej) los yog Wi-Fi;
 - Yog hais tias koj tus me nyuam xav tau txhua yam khoom tseem ceeb lossis tshuab technology (assistive technology); los yog,
 - Yog hais tias koj xav teem caij rau qhov kev sib tham hauv computer los yog hauv xov tooj (virtual or telephonic) rau IEP.
- Lub District nkag siab zoo tias qhov no yog ib sij hawm nyuab rau hais tsis paub meej rau tej yim neeg thiab cov tub/ntxhais kawm ntawv. Peb tab tom ua txhua yam li ua tau rau qhov ua hauj lwm zoo tshaj plaws rau tag nrho cov tub/ntxhais kawm ntawv tau txais kev zoo thiab tau txaus koj tus me nyuam tej kev xav tau sij hawm tab tom ua hauj lwm kom “kab mob tsis txhob nce siab siab” (“flatten the curve”) thiab paub tseeb kom muaj kev noj qab haus huv thiab kev dawb huv zoo rau tag nrho sawv daws. Peb thov nej muab kev txhawb pab nyob rau cov kev muab txiaiv txim ua no.

- Thov rov qab xyuas dua rau tag nrho District tej kev sib tham cev lus hais txog COVID-19, muaj tag nrho tej kev muab mov cov tub/ntxhais kawm ntawv noj thiab lwm cov kev pab rau kev kawm ntawv, uas yog tau npaj los ntawm tsev kawm ntawv cov lus faj tuaj, lub District lub website (www.fresnounified.org), thiab lub District's social media channels. Yog hais tias koj muaj txhua yam tej lus nug, koj hu mus rau lub District's COVID-19 hu rau qhov chaw (center) yog (559) 457-3395.
