Daim ntawv no yog yuav npaj hais qhia paub tseeb rau kev kawm ntawv tshwj xeeb cov neeg ua hauj lwm hais txog IEP muab kev ua los yog qhia sij hawm tab tom kaw tsev kawm ntawv tau muab sij hawm rub ntev mus ntxiv. Ib Pab Thawj Coj Kev Ua qhov twg yog muab kev teev cov ntsiab tseem ceeb rau lub District Txoj Kev Npaj (District Plan) nyob rau Seb Yuav Ua Li Cas rau Ua Ntej Ua Tau Zoo Sij Hawm Nrug Deb Muab Kev Xyaum Kawm (Accomplish Distance Learning Priorities).

Tsoom Fwv thiab Xeev Kev Qhia Ua Sij Hawm Tsev Kawm Ntawv Tab Tom Raug Kaw (Federal and State Guidance During School Closure)

- Tub/Ntxhais Kawm IEPs, muaj tag nrho kev kawm ntawv tshwj xeeb thiab cov kev pab cuam muaj zoo ib yam, yuav tsum tau muab ua rau qhov ntev mus ntxiv li ua tau.
- IEP cov pab cuam yuav tsum tau muab xa tawm los ntawm qhov qauv qhia kev xyaum sij hawm rub dej
- IEP rooj sib tham yuav tsum tau muaj yog hais tias ua tau los ntawm siv nyob rau hauv tshuab hlwb hlauv sib pom tus neeg rau sib tham (video conference), hu xov tooj, tej
- Sij hawm tab tom muab kev soj ntsuam tshau thiab IEP sij hawm ua ntu zus (thawj zaug, txwm xyoo, thiab peb xyoos) yuav tsis tau tso tseg lossis tau mub rub ntev mus ntxiv, qhov USDOE thiab CDE mam li "npaj kev ua kom tau yooj yim li qhov twg ua tau" thiab muab qhov "kev muaj nuj nqis ua raws li txoj cai hais kom ua."

Nyob rau cov lus hais, kev qhia saum toj no yog tau npaj rau pab cov thawj coj thiab neeg ua hauj lwm muaj kev txhawb pab los ntawm qhov chaw kev kawm ntawv tshwj xeeb tus neeg ua hauj lwm.

- Cov Case Managers yuav hu rau niam txiv/tus neeg saib xyuas rau txhua tus tub/ntxhais kawm ntawv nyob rau tus neeg tuav lawv cov ntaub ntawv (caseload) rau sib tham txog qhov qauv qhia kev xyaum sij hawm nrug deb rau lawv tus tub/tus ntxhais sij hawm tsev kawm ntawv tab tom raug kaw
- Nyob ib yam nkaus nrog qhov muaj tshiab tshiab tshaj plaws FTA/FUSD Kev Xyaum Sib Tham Cev Lus Nrug Deb, Kev Kawm Ntawv Tshwj Xeeb cov neeg muaj ntuj yuav:
 - Yuav Qhia, Xyaum, thiab Kawm Ua Ke Mus Ntxiv
 - Naj cov cib fim kev xyaum rau txhua tus tub/ntxhais kawm ntawv nyob rau tsawg kawg ib zaug ib asthiv
 - Sib tso ua ken rog txhua tus tub/ntxhais kawm ntawv nyob tsawg kawg ib zaug ib

- Sib cog ua nyob rau tus neeg muaj txuj kev xyaum li tej kev rau txhawb pab kev xyaum nrug deb
- Qhov muaj IEP cov rooj sib tham yog hais tias ua tau thiab kev siv li ua tau kev sib tham nyob rau hauv tshuab hlwb hlau (video conference), hu xov tooj, tej (Nws yog nyob rau txhua tus qhov kev txaus siab tshaj plaws rau muaj kom ntau li ntau rau cov rooj sib tham li muaj tau sij hawm tab tom raug kaw rau qee tus naj npawb rau IEP cov rooj sib tham kom tsawg thaum tsev kawm ntawv rov qab qhib kawm mus)
- Cov Case Managers hu rau cov neeg qhia ntawv pab (paraprofessionals) hais txog lawv txoj kev ua hauj lwm nyob rau muab kev txhawb pab cov tub/ntxhais kawm ntawv zoo li yog kev koom ua ke lub chav muab kev qhia ntawv nyob rau hauv tshuab hlwb hlauv (virtual class), hu rau cov niam txiv, tej
